


CARDS, SIGN, AND PHOTOS



We provide participating libraries with printed and visual agenda cards, a sign, and a photo release form in the first box.

Visual Agenda Cards Pages 6-15

To give your audience a glimpse of what to expect in your storytime, use visual agenda cards. They can help ease anxiety or uncertainty and help kids manage expectations. If kids know what is happening next, they are more likely to participate and engage in the storytime.

Photocopy the cards on pages 6-15 or use the download link to print. Blank cards are included for you to create new tasks. [Download more visual agenda cards.](#)

Optional: Laminate the cards to make them more durable. Tape each card, in order of use, to a wall or board. You can even add hook and loop tabs to the back to be used on a felt board. As you complete an action, remove the card from the timeline so participants can follow along.




Photo Release Page 17


