## **OFFICIAL RULES**

- **2.** Ticket packets will be mailed to targeted zip codes. Go to **kpts.org** to enter online. Tickets can also be purchased by calling **(316) 838-3090**. There is no limit on the number of entries.
- **3. PBS Kansas** employees and members of their household are not eligible to participate. Employees of Dunning & Associates, CPAs, LLC are also not eligible to participate.
