## DAY ONE ~ TRAVEL TO CAPE COD MASSACHUSETTS

Departing Owings Mills early this morning, you will head north to Cape Cod, Massachusetts. Rest and lunch (at your own expense) stops will be made en route. Arriving on the Cape later this afternoon, you will check into your hotel. Dinner is included this evening at a local restaurant. **Hotel: Fairfield Inn & Suites Cape Cod, Hyannis, MA.**

## DAY TWO ~ CAPE COD NATIONAL SEASHORE VISITOR'S CENTER ~ WHALE WATCH CRUISE OR DUNE TOUR

After breakfast at the hotel this morning, say hello to your local guide who will join you as you board your motorcoach for a full day of touring. You will travel historic Route 6A, the Old King's Highway, a scenic byway winding through centuries of Cape Cod history. It winds past hundreds of historic structures which characterize its early development. Along the way, view the **Eastham Windmill**, a **Cape Cod Lighthouse** and visit the **CAPE COD NATIONAL SEASHORE VISITOR'S CENTER**.

Sand dunes and the ocean surround you as you approach "Land's End" – **PROVINCETOWN**. You are now at the extreme tip of Cape Cod. Formerly known as the "Province Lands" the pilgrims landed here first before they decided to settle across the Bay in Plymouth. Take some time to enjoy the wonderful variety of restaurants, shops, and galleries that make this artists/fishermen village so unique. Lunch is on your own here today.

This afternoon, board an excursion vessel for an amazing experience of **WHALE WATCHING**. You will travel into the natural habitat of a diverse marine environment including birds that migrate here from all over the Atlantic, and fish which use these shallow waters to feed. Try to spot Humpback, Minke, and Fin Whales going about their daily business. An onboard naturalist will introduce you to everything you see and will answer any of your questions about the whales, birds, fish and lighthouses.

**OR YOU MAY CHOOSE TO STAY ON DRY LAND FOR A DUNE TOUR.** Ride along the shoreline of the protected lands of the Cape Cod National Seashore. On your Dune Tour, your guide will point out the "dune shacks" where famous artists and writers became inspired to create their art.

Dinner is included this evening at a local restaurant. **Hotel: Fairfield Inn & Suites Cape Cod, Hyannis, MA.**

## DAY THREE ~ CAPE COD CENTRAL RAILROAD ~ CAPE CANAL VISITOR'S CENTER ~ BOSTON

After breakfast and checkout, you will proceed later this morning to the **CAPE COD CENTRAL RAILROAD** for the first of your coastal train excursions. Aboard the train, you'll have panoramic views of the beautiful seaside scenery. Enjoy an included boxed lunch as you pass beautiful cranberry bogs, natural woodlands, and lush marshes as you make your way from Hyannis to the Cape Cod Canal and past Sandwich, MA, the oldest town on Cape Cod. Sandwich became the site of one of America's largest glass factories, an industry that flourished during the 19<sup>th</sup> century. You will have time to visit the **CAPE CANAL VISITOR'S CENTER** following the train ride.

Board your motorcoach in the midafternoon and depart with sand in your shoes and many fond memories of your visit to Cape Cod as you travel to Boston. Later this afternoon, check into your Boston area hotel for the next two nights. Dinner included at a local restaurant. **Hotel: Courtyard by Marriott, Woburn, MA.**

**Meals: Breakfast, Boxed Lunch, Dinner**

## DAY FOUR ~ TALL SHIP CRUISE ~ BOSTON TEA PARTY SHIPS & MUSEUM ~ QUINCY MARKET ~ FANEUIL HALL

Breakfast is included this morning at the hotel. Today embark upon your **TALL SHIPS CRUISE** of the **BOSTON HARBOR** aboard the **SPIRIT OF BOSTON** or the **ODYSSEY** (both comparable harbor cruise ships). Your harbor cruise captain will show you the best views of these fine ships! **Note:** Your cruise will be one of the following: Brunch Cruise, Buffet Luncheon Cruise, or Afternoon Refreshments Cruise. To be determined based on City Cruises 2026 schedule. After the cruise, you will spend the afternoon **EXPLORING** the **TALL SHIPS** on your own as they are docked in the harbor.

Tall ships from around the world will dock at Boston Harbor from July 11-16, 2026. The event is called Sail Boston and will welcome ships and sailors from all over the world in a special tribute to the 250th anniversary of America's founding. The event is part of Sail 250, a global gathering of tall ships to celebrate the 250th anniversary of the founding of the United States.

In the late afternoon, visit the **BOSTON TEA PARTY SHIPS AND MUSEUM**. You will have a personal "colonial character" guide you through the BOSTON TEA PARTY SHIPS & MUSEUM. The museum features full-scale replicas, artifacts and interactive elements. Meet "Sam Adams" and participate in the re-enactment of the destruction of the tea. Board a tall ship and marvel at one of only two known surviving tea crates.

Dinner is on your own this evening at **QUINCY MARKET**. For over 250 years the marketplace has played an integral role in the life of Boston's residents. You will feel the cobblestones beneath your feet, see roaming performers and be able to taste the wonderfully diverse ethnic foods available for purchase. There are 100 shops, carts and artisans to offer treasures for you to take home with you! You will have time to visit **FANEUIL HALL**, which has served as a meeting hall and a place where merchants can market their wares since 1742. Following dinner you will return to your hotel. **Hotel: Courtyard by Marriott, Woburn, MA. Meals: Breakfast, Lunch**

#### **DAY FIVE ~ MT. WASHINGTON COG RAILWAY ~ WHITE MOUNTAINS ~ CAFÉ LAFAYETTE DINNER TRAIN**

Breakfast is included at your hotel this morning. After checking out of your hotel you will travel to New Hampshire where you will meet your local guide at the **MT. WASHINGTON COG RAILWAY** in Mt. Washington, NH. From the base station you will enjoy a scenic train ride to the summit of Mount Washington, the Northeast's highest peak! On a clear day you will enjoy views of Maine, Massachusetts, New Hampshire, New York, Quebec, Vermont, and the Atlantic Ocean. A boxed lunch will be provided aboard the train today. The round-trip cog ride takes approximately three hours, including approximately one hour stop at the summit. At the summit you will find the Sherman Adams Visitor Center. The visitor's center includes a rooftop observation deck, an interactive weather exhibit called Extreme Mount Washington, a cafeteria, and two gift shops. Also at the summit is Tip Top House, the original summit hotel, dating back to 1853 which is now a museum that's believed by many to be the oldest existing mountain top hostelry in the world. You'll also find a summit sign, which is a favorite spot to take selfies and the Summit Post office, where you can send a card with a Mount Washington postmark.

After time to explore the summit, you will take the cog railway back down to the base station where you will board your motorcoach and continue touring through the **WHITE MOUNTAINS**. Travel through notches cut from the glaciers and enjoy the scenic nature of New Hampshire. Your guide is well versed in the history, geology and lore of the area. These fascinating details will be imparted to you as enjoy your travel from place to place today.

Late afternoon you will arrive at the Café Lafayette Dinner Train for check in and boarding. Aboard the **CAFÉ LAFAYETTE DINNER TRAIN** you can escape the ordinary and relive the romance of dining on the rails. Experience this while riding in one of three beautifully restored Pullman dining cars, enjoying five courses of fine food served to you in the Grand European manner. With salad greens, herbs and edible fresh flowers, fresh meats, poultry, seafood and homemade rolls through dessert, you are guaranteed the unusual and the delicious. As dinner is served, period music keeps time with the rail's rhythmic rumbling, punctuated by the haunting wail of the engine's whistle. With magnificent mountain vistas and lush New England forests surrounding The Café Lafayette Dinner Train, you are assured of having the best seat in the house, all evening long. After dinner, with the compartment lights down low and the dramatic sunset outside your window, you may allow yourself a wistful romantic journey back in time. Following your train ride you will board your motorcoach and will be transferred to Lincoln, NH where you will check into your hotel for the evening. **Hotel: The Mountain Club on Loon Resort, Lincoln, NH. Meals: Breakfast, Boxed Lunch, Dinner**

#### **DAY SIX ~ MS MOUNT WASHINGTON ~ WRIGHT MUSEUM ~ WINNIPESAUKEE SCENIC RAILROAD DINNER TRAIN**

Breakfast is included at the hotel this morning. After breakfast, meet your local guide and travel south to Lake Winnepesaukee. Here you will take a scenic cruise on **LAKE WINNIPESAUKEE** aboard the **MS MOUNT WASHINGTON** to Wolfeboro, the oldest summer resort in America. Enjoy lunch on your own here today and free time for shopping in this delightful lakeside town. After lunch, tour the **WRIGHT MUSEUM** - a museum about the World War II years with both war exhibits such as aircraft and tanks and exhibits from everyday life. You will also visit the **OLD COUNTRY STORE AND MUSEUM** in Moultonborough, NH. This general store was established 1781 and quite possibly the oldest retail store in America and a historical must-visit.

In the late afternoon arrive at the **MEREDITH STATION** of the **WINNIPESAUKEE RAILROAD TURKEY DINNER TRAIN**. Board the **WINNIPESAUKEE SCENIC RAILROAD** for a two-hour trip along Lake Winnepesaukee. Ride the rails while eating **HARTS HOT ROAST TURKEY** with all the trimmings! Following dinner, return to your hotel.  
**Hotel: Mountain Club on Loon Resort, Lincoln, NH. Meals: Breakfast, Dinner**

#### **DAY SEVEN ~ TRAVEL TO MASSACHUSETTS ~ BOSTON SYMPHONY ORCHESTRA CONCERT AT TANGLEWOOD**

Breakfast is included at the hotel this morning. After breakfast, depart for Lenox, Massachusetts. Afternoon arrival at Tanglewood where you will have time to have lunch on your own. Then enjoy the **BOSTON SYMPHONY ORCHESTRA CONCERT** at **TANGLEWOOD** with inside Shed ticket at the Tanglewood Music Shed which is an indoor amphitheater. The Shed was built in 1938 and like a farm shed, designed with three open sides. The difference is that the acoustical perfection of the Tanglewood Music Shed makes it an ideal place to hear the Boston Symphony Orchestra. This is an experience unique only in the Berkshires. After the concert check into the hotel with time to freshen up before your included dinner. **Hotel: Fairfield Inn & Suites Berkshires, Great Barrington/Lenox, MA. Meals: Breakfast, Dinner**

#### **DAY EIGHT ~ TRAVEL HOME**

After breakfast and check out, you will depart for home with fond memories of New England coastal trains and tall ships. Rest and meal stops (at your own expense) will be made en route. **Meals: Breakfast**

**The following exclusion applies to the Trip Cancellation and Trip Interruption:** We will not pay for any loss or expense caused due to, arising or resulting from a Pre-Existing Medical Condition, as defined in the plan.

**The following exclusions apply to the Medical Expense benefits:**

1. routine physical examinations or routine dental care;
2. traveling for the purpose or intent of securing medical treatment or advice;
3. Alcohol or substance abuse or treatment for the same;
4. Normal pregnancy (except Complications of Pregnancy) or childbirth, or elective abortion;
5. a Mental, Nervous or Psychological Condition or Disorder unless Hospitalized or Partially Hospitalized while the certificate is in effect;
6. Your participation in Adventure or Extreme Activities, riding or driving in races, or participation in speed or endurance competition or events, except as a spectator;
7. Your participation in an organized athletic or sporting competition, contest, or stunt under contract in exchange for an agreed-upon salary or compensation. This does not include athletes participating in exchange for a scholarship or tuition;

We will not pay for any loss or expense caused due to, arising or resulting from:

1. suicide, attempted suicide or any intentionally self-inflicted injury of You, a Traveling Companion, Family Member or Business Partner booked and scheduled to travel with You, while sane or insane;
2. being under the influence of drugs or narcotics, unless administered upon the advice of a Physician as prescribed;
3. activities, losses, or claims involving or resulting from possession, production, processing, sale, or use of marijuana, illegal drugs, alcohol or substances are excluded from coverage;
4. war or act of war, including invasion, acts of foreign enemies, hostilities between nations (whether declared or undeclared), or civil war;
5. the commission of or attempt to commit a felony or being engaged in an illegal occupation by You, a Traveling Companion, Family Member, or Business Partner;
6. directly or indirectly, the actual, alleged or threatened use, discharge, dispersal, seepage, migration, escape, release or exposure to any hazardous biological, chemical, nuclear radioactive weapon, device, material, gas, matter or contamination;
7. piloting or learning to pilot or acting as a member of the crew of any aircraft.
8. failure of any tour operator, Common Carrier, or other travel entity, person or agency to provide the bargained-for

Travel Arrangements for reasons other than Financial Insolvency or Financial Default.
